## **2 CASES OF CARS SUBJECT TO RECALL**

Effective from October 1, 2023, the Government's Decree 60/2023/ND-CP dated August 16, 2023 stipulates the inspection and certification of quality, technical safety and environmental protection of imported automobiles and components under international treaties to which Vietnam is a signatory.

In particular, the Decree stipulates that cars subject to recall include:

- + Recalled cars as announced by the manufacturer;
- + Recalled cars at the request of inspection agencies. The recall request of the inspection agency shall be made on the basis of specific evidence, the results of verification of information reflecting on the quality of technical safety and environmental protection of imported automobiles.

## ELECTRONIC RECEIPTS FOR COLLECTION OF MONEY IN CIVIL JUDGMENT EXECUTION

Circular 04/2023/TT-BTP (effective on 01/10/2023) guiding the implementation of a number of procedures on administrative management and professional forms in civil judgment execution.

Accordingly, electronic receipts collected in civil judgment execution are as follows:

The content on the electronic receipt is fully entered according to the form based on the information provided by the payer, information from other agencies sent to the civil judgment enforcement agency related to the electronic receipt.

The preparation of electronic receipts shall be carried out by the Executors and employees of the assigned civil judgment enforcement agencies.

Electronic receipts on the digital application platform are looked up according to the lookup code provided by the civil judgment enforcement agency.

# REGISTRATION OF CIRCULATION OF PROCESSED DRUGS

Circular 16/2023/TT-BYT of the Ministry of Health takes effect on October 1, 2023 stipulating circulation registration for processed drugs and technology transfer drugs in Vietnam.

This Circular provides general regulations on circulation registration of processed drugs and technology transfer drugs manufactured in Vietnam; dossiers and procedures for granting, extending, changing, supplementing and revoking circulation registration certificates of processed drugs and technology transfer drugs (pharmaceutical chemical drugs, vaccines, bio-products, medicinal drugs) in Vietnam.

The Circular applies to domestic and foreign agencies, organizations and individuals involved in drug processing and drug technology transfer activities in Vietnam.



# FROM 22/10, EXEMPTION FROM REGISTRATION FEE, ISSUANCE OF LICENSE PLATES OF SPECIALIZED THREE-WHEELED MOTORCYCLES FOR PEOPLE WITH DISABILITIES

According to Circular 60/2023/TT-BTC dated September 7, 2023 stipulating the collection rate, regime of collection, payment, exemption and management of fees for registration and issuance of road motor vehicle plates effective from October 22, 2023, exemption from registration fees and issuance of number plates for specialized three-wheeled motorcycles for people with disabilities.
