REGULATIONS ON FREEZING ASSETS OF INSPECTED SUBJECTS

Decree No. 43/2023/ND-CP detailing a number of articles and measures to implement the Inspection Law takes effect from August 15.

The Decree specifies grounds for requesting the freezing of accounts of inspectors, including:

Inspected subjects showing signs of asset evacuation, including: Making or preparing to make money transfer transactions through other accounts with unclear information about the purpose, content and recipient; showing signs of shifting ownership, right to use, donate, mortgage, pledge, destroy or change the current status of property; acts of falsifying accounting records and books leading to changes in assets.

Inspected subjects fail to comply with the time for handing over money and assets according to decisions on recovery of money and assets of inspection agencies or competent state management agencies.

INCREASE IN DRIVING TEST FEES

Circular No. 37/2023/TT-BTC takes effect from August 1, replacing Circular No. 188/2016/TT-BTC dated November 8, 2016, regulating the collection rate, regime of collection, payment, management and use of driving test fees; fees for issuance of licenses and certificates of operation on vehicles and fees for registration and issuance of specialized motorcycle plates.

In particular, the notable point in Circular No. 37/2023/TT-BTC is the increase in driving test fees. Specifically, for the driving test of classes A1 to A4, the theory is 60,000 VND/time; practice 70,000 VND/time (increase 20,000 VND).

For the driving test of class B1, B2, C, D, E, F respectively, the theory is 100,000 VND/time (an increase of 10,000 VND); practice in the picture 350,000 VND/time (increase 50,000 VND); Practical test on the road 80,000 VND (an increase of 20,000 VND), in addition, students also have to drive a car with software that simulates traffic situations with a fee of 100,000 VND / time.

COMMUNE-LEVEL POLICE SHALL ISSUE CERTIFICATES OF ELIGIBILITY FOR SECURITY, ORDER AND MANAGEMENT OF BUSINESS FACILITIES

Effective from July 15, 2023, Decree No. 56/2023/ND-CP dated July 24, 2023 amending and supplementing a number of articles of Decree No. 96/2016/ND-CP dated July 1, 2016 stipulating security and order conditions for a number of conditional investment and business lines.

In particular, the supplementary Decree stipulates that commune-level police are responsible for issuing certificates of eligibility for security, order and management of business establishments, including: accommodation service establishments with a business scale of less than 10 rooms, gas trading establishments being business households.
