SUPPORT FOR FOREST PROTECTION WITH AN AVERAGE OF 300,000 VND/HA/YEAR

Circular 21/2023/TT-BTC of the Ministry of Finance stipulating the management and use of non-business funds for the implementation of the Program on Sustainable Forestry Development in the period of 2021-2025 takes effect from June 1, 2023.

Accordingly, the average forest protection support level is 300,000 VND/ha/year. For coastal forest protection contracts, the maximum support level is equal to 1.5 times the average support level. The budget for making forest protection dossiers is 50,000 VND/5 years. The financial support for the preparation of forest protection contracts is only done 1 time before conducting forest protection contracts.

Support to protect production forests that are natural forests during the specific forest closure period as follows: Forestry companies: 300,000 VND/ha/year; forest management board, commune-level People's Committee: VND 100,000/ha/year; households, individuals, residential communities and organizations allocated natural forests by the State as natural forests: VND 300,000/ha/year.

DON'T USE DOCTOR IMAGES TO ADVERTISE MULTI-LEVEL SALES

The Government promulgates Decree No. 18/2023/ND-CP dated April 28, 2023 amending and supplementing a number of articles of Decree No. 40/2018/ND-CP dated March 12, 2018 on management of business activities in a multi-level manner.

Multi-level selling enterprises do not provide information about food in the form of using images, equipment, costumes, names, letters of medical units, facilities, doctors, pharmacists, medical staff, thank you letters, thank you letters of patients, doctors' articles, etc pharmacists, medical workers; Do not provide information about foods that post, quote, quote or state opinions of patients describing foods that have therapeutic effects.

Decree No. 18/2023/ND-CP takes effect from June 20, 2023.

CONDITIONS FOR BEING GRANTED CERTIFICATES OF TRAINING PROGRAMS FOR CADRES, CIVIL SERVANTS AND PUBLIC EMPLOYEES

Effective from June 15, 2023, Circular 03/2023/TT-BNV of the Ministry of Home Affairs guiding a number of provisions of Decree No. 101/2017/ND-CP on training and fostering cadres, civil servants and public employees and Decree No. 89/2021/ND-CP amending and supplementing a number of articles of Decree No. 101/2017/ND-CP.

The Circular specifies conditions for being granted certificates of training programs for cadres, civil servants and public employees. Accordingly, the certificate of the refresher program is issued to students who fully meet the following conditions:

1. To participate in full study in accordance with the provisions of the fostering program.
2. Having sufficient examinations, harvest writing, essays and schemes as prescribed by the fostering program; Tests, harvest writing, essays, schemes must score 50% or more according to the scale prescribed by the program.
3. To strictly and fully abide by the provisions of law on fostering cadres, civil servants and public employees; regulations and rules of study of the National Academy of Public Administration; training and retraining institutions; training and research institutions.

The certificate of the refresher program is issued 1 time to students who complete the course, on the closing day of the course.

100% OF THE RESULTS OF ADMINISTRATIVE PROCEDURE SETTLEMENT DOSSIERS ARE PROVIDED SIMULTANEOUSLY ELECTRONICALLY

According to Decision No. 13/QĐ-BCĐCCHC of the Steering Committee for Administrative Reform of the Government, digitize records and settlement results for administrative procedures within the scope of reception of the commune-level One-Stop Department (except for communes in deep-lying, remote areas, extremely difficult areas, borders, islands); 100% of the results of administrative procedure settlement dossiers are provided simultaneously with electronic versions with full legal validity for people and businesses.

The decision takes effect June 1, 2023.
